Approval of April Minutes:

Treasurer's Report:

- Alright, almost to the end of the year, the last report will capture the checks and all the teacher appreciation expenses.
- As it stands, we started out the month with the bank account at \$97,511.06, and ended at \$82,537.99.
- This month we had a lot of spending from the teacher grant program, we actually went over budget, but if you look at the spreadsheet, as a whole, we still are under budget for the year.
- The last of the big expenses next month will be the remainder of the teacher grants, as well as teacher appreciation week. We had a sponsor for this year's teacher appreciation lunch: Sweetwater Restoration, and a sponsor for the teacher gifts was Bright Smiles Pediatric Dentistry. Additionally, we have a few new business partners: Jacksonville Children's Chorus, Bright Smiles Pediatric Dentistry.
- Our new school supply kit company graciously paid the cancellation fee we incurred from our old company, and that will be reflected on next month's statement.
- Finally, the last big expense this month, not formally budgeted for, but approved by the PTO, which is the LEGO Spike kits (\$5,049). Ms. Pietri presented a plan to the PTO for use in class, and to start-up an afterschool STEM program for the 2024-2025 school year.

PTO Board 2024/2025 voting: All voted in favor.

Principal Update:

- Thank you for all the things for Teacher/Staff appreciation weeks.
- Everyone at the school loved the decorations and loved looking for photos.
- Finishing up testing right now.
- Budget for new school year has been done.
- We had to give \$64,000 back to the district. Not instructional staff for budget back.
 - We are supposed to have associate teachers next year, but we canceled that to hold the funds down.
- We are not planning to over count in any grade levels besides Kindergarten and First Grade.
- Kindergarten count is low right now 32 usually 64 at this time.
- The principal is going to do school tours to open the doors to parents.
- ESE department is changing to access units, students in wheelchairs and other needs this upcoming school year and 9 new adults.
- Playground- Café playground is becoming the access playground.
- Willy Wonka playground has had items removed that make it unsafe and its on plan to get redone.
 - They are done with budget meetings, but risk management is coming to look at the playground.
 - What is the school able to provide and the district will do the rest. Project for the next school year.
- The Principal has written a request for a shared principal to the district because we have to lose head count of one of the principals.
- 816 right now 725 predictions for school population. Expecting the number to increase the next school year. 2024-2025 will be low population, then expected to raise in 2025-2026.
